## **Summer School Program 2024**

### About the program

From July to August, the German students will stay at Coastal Carolina University for a three-week period.

Participants of this program will learn about American business practices, economy, and culture from a global perspective and improve their English oral and written skills. Students will attend a series of seminars designed for this program that are presented by Coastal Carolina University faculty. The participants will meet international students from other European countries as well as from the U.S.

Students will visit a local company and go to the Myrtle Beach Area Chamber of Commerce (an organization that supports business and promotes tourism in the area).

They work in teams with local organizations and will conduct experiential studies for the organization, learn about the organization and create a consulting report for the company. Students will also participate in fun activities during the week like golf lessons and a visit to Brookgreen Gardens, which has the largest collection of American sculptures in the world.

# Examples of consulting projects

#### **Chamber of Commerce**

The Chamber of Commerce helps support local businesses and helps promote Myrtle Beach as a tourist destination. Students worked in a team to consult the Chamber on attracting more European tourists to the Grand Strand.

#### Coastal Carolina Athletics

The Athletics Department at Coastal Carolina University is responsible for managing and promoting the university sports teams while complying with NCAA rules. Students advised the Athletics Department on attracting and retaining athletes from abroad.
